2. Medicare Part B Premium Reimbursements (Income Adjustments, 0% Retirees and Spouses of Self Only Retirees)

Mr. Mizuno summarized the proposed EUTF Administrative Rule changes for Medicare Part B Premium reimbursements (income adjustments, 0% retirees and spouses of self only retirees). Discussion held by the Trustees and staff regarding concerns about these proposed changes and that further discussion needs to be held by the Board. Mr. Mizuno reported that this is for the Trustees information only and summarized the electronic payment options that the EUTF would like to offer to the membership.

C. Reserves of Unrestricted Net Assets

Mr. Mizuno summarized the EUTF staff's recommendation to change the reserve of unrestricted net assets from a set dollar amount for the self-funded prescription drug plan to 35% of the most recent fiscal year self-funded prescription drug plan claims and expenses.
