V. NEW BUSINESS

A. Administrative Rules – Consideration of Proposed Amendments

Summary by Chair Recktenwald regarding why the Administrative Committee is reviewing the Administrative Rules. Chair Recktenwald stated the deputy attorney general did not review these proposed amendments. Overview by Mr. Nishihara and Mr. Williams regarding proposed amendments to the Administrative Rules (see table). Discussion held by Trustees, staff, and public regarding the proposed amendments to the Administrative Rules.

By consensus of the Trustees, the Administrative Committee tentatively approved the following proposed amendments to the Administrative Rules:

Sections 1.02 with changes, 3.01(b)(4) with changes, 3.01(b) last paragraph, 4.11(a), 4.12(c), 5.01(a), 5.01(d) last paragraph, 5.02(a)(1), 5.02(b), 5.03, 5.03(a) with changes, 5.05(b) last paragraph with changes, 5.05(c) with changes, and 5.06(b).

Proposed amendments withdrawn: Sections 4.05(a), 4.11(c), and 5.01(a).

Proposed amendments on hold for discussion: Sections 4.12(e), 5.05(a), 5.02(a) last paragraph, 5.05(b)(6), and 5.06(f).

The proposed amendments to the Administrative Rules will be submitted to the Deputy Attorney General for review. The EUTF staff will submit proposed amendments to the Administrative Rules in Ramseyer format at the next Administrative Committee meeting in January 2006.

VI. COMMUNICATIONS FROM THE PUBLIC AND INPUT FROM ATTENDEES

Mr. Williams reported on the following: (1) Letters received from the Office of Hawaiian Affairs, University of Hawaii, and the City and County of Honolulu saying they have no comments and/or changes and also thanking the Board for giving them the opportunity to comment and/or submit suggested changes to the Administrative Rules; and (2) The Judiciary suggested that reference to HIPAA be included in the Administrative Rules. By consensus of the Trustees, the Administrative Committee will also consider the Judiciary's suggestion at the next Administrative Committee meeting.
