Plan Coverage During COVID-19 Pandemic

During this uncertain time, please be assured that your health coverage through the EUTF remains in place. Additionally, the EUTF Board has taken measures to provide an additional level of comfort that goes beyond the federally mandated coverage.

HMSA members: Effective March 1 through June 30, 2020:

1. All services related to the diagnostic testing of COVID-19 are 100% covered (physician referral required).
2. All services related to the treatment of COVID-19 are 100% covered.
3. All telehealth services, including non COVID-19 related services are 100% covered.

CVS members: To retain an emergency supply, members can obtain an extra 90-day supply of maintenance medications.

KP members: All COVID-19 related diagnosis and testing services from March 5, 2020, including office/urgent care/ER visit, associated labs, and radiology, are 100% covered (available with a doctor's order only). All inpatient and outpatient services related to the treatment of COVID-19 are 100% covered effective April 1 through May 31, 2020.
