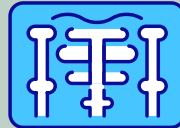

# Make 2023 a healthy year and win big!

Every day is a victory when you make staying healthy your goal. Don't wait until you're sick to see the doctor. Going to the doctor for preventive care is your best winning strategy.

With HMSA, it's easy to get preventive care because your health plan includes an annual checkup at no cost when you see a primary care provider in HMSA's network. This annual evaluation checks your overall health and identifies potential health conditions early. Your PCP will work with you to determine which screenings are recommended for you.

There's another way to win. **If you visit your PCP for an in-person annual evaluation and log in to My Account, you'll be entered in a drawing for a chance to win a \$1,500 Visa gift card. Virtual and phone appointments don't qualify for entry.**

## STEP 1 Schedule your exam



Call your PCP to schedule your annual evaluation.

Having a PCP means you have a health care partner who can help you track your progress toward your health and well-being goals and answer any questions you may have about medications, treatment plans, or other health issues. EUTF or HSTA VB retirees without Medicare can complete their physical exam with their PCP by Oct. 31, 2023, for a chance to win a \$1,500 Visa gift card. If you're an EUTF or HSTA VB retiree with Medicare, complete your Medicare wellness exam with your PCP by Oct. 31, 2023, for a chance to win a Visa gift card. Members who complete their exam between July 1, 2022, and Oct. 31, 2023, are eligible for entry.

## STEP 2 Log in to My Account



Log in to My Account on [hmsa.com/eutf](https://hmsa.com/eutf) by Oct. 31. To register for My Account, click Member Login, use your personal email address, and enter your HMSA subscriber ID number. If you're already registered, log in and confirm that your email address is current.
