I. CALL TO ORDER

The meeting of the Benefits Committee of the Hawaii Employer-Union Health Benefits Trust Fund (EUTF) was called to order at 9:01 a.m. by Trustee Osa Tui, Chairperson, in the EUTF Board Room, 201 Merchant Street, Suite 1700, Honolulu, Hawaii, on Tuesday, August 15, 2023.

Chairperson Tui announced that Roderick Becker resigned from the Board.

II. REVIEW OF MINUTES – May 16, 2023

The Benefits Committee reviewed the draft minutes of May 16, 2023.

MOTION was made and seconded to approve the minutes of May 16, 2023, as circulated. (Ferguson-Miyamoto/Wataru) The motion passed unanimously. (Employer Trustees-2/Employee-Beneficiary Trustees-4)

III. NEW BUSINESS

A. Kaiser Permanente Medical Plan Changes

Mr. Troy Tomita and Mr. Thomas England, Kaiser Permanente, proposed increasing coverage of hearing aids to 80% of the hearing aid cost for each hearing-impaired ear every 36 months which Kaiser is doing for their book of business. Kaiser provided the following options:

- Option 1: Increase coverage of hearing aids to 80% for each hearing-impaired ear every 36 months under the EUTF and HSTA VB Kaiser active employee and retiree medical/prescription drug plans effective July 1, 2024 and January 1, 2025, respectively.
- Option 2: Add hearing aid coverage at 40% to the EUTF and HSTA VB Kaiser retiree medical/prescription drug plans effective January 1, 2024 or 2025.

Mr. Stephen Murphy, Segal Consulting, presented a memo comparing the proposed Kaiser coverage with national and HMSA coverage noting that Option 1 is more in-line with these groups. EUTF staff estimated that the increase in the retiree premiums under options 1 and 2 would increase the unfunded liability by approximately \$10 million and \$5 million, respectively. The unrestricted, unreserved net assets in the retiree agency fund was \$288 million at May 31, 2023.

Trustees Sabrina Nasir and Wesley Machida joined the meeting during the presentation, at 9:07 a.m. and 9:11 a.m., respectively.

MOTION was made and seconded to recommend to the Board increasing hearing aid coverage to 80% under the EUTF and HSTA VB Kaiser Permanente active employee medical/prescription drug plans effective July 1, 2024. (Wataru/Ferguson-Miyamoto) The motion failed. (Employer Trustees-2 YES Hidano, Nasir, 2 NO Machida, Yu/Employee-Beneficiary Trustees-4 YES Ferguson-Miyamoto, Tui, Wakuzawa, Wataru)

MOTION was made and seconded to recommend to the Board adding hearing aid coverage at 40% to the EUTF and HSTA VB Kaiser Permanente retiree medical/prescription drug plans effective January 1, 2024 and moving \$5 million from the EUTF Trust Fund to the OPEB Trust. (Ferguson-Miyamoto/Wataru) The motion passed unanimously. (Employer Trustees-4/Employee-Beneficiary Trustees-4)

B. HMSA Payment Transformation

Mr. Justin Yoshimoto, HMSA, provided an update on payment transformation focusing on the following:

C. HMSA Update on Member Engagement in Model of Care for Condition Care and Complex Case Management Programs

Ms. Sarah Gunderson, Segal Consulting, provided an overview of model of care and complex case management programs nationally and the enrollment challenges. She also noted that although HMSA's enrollment numbers are lower than those of mainland counterparts, it has improved in 2022.

Ms. Alyson Kusatsu and Ms. Joy Narciso, HMSA, provided an update on the Model of Care complex case management, event driven care, condition care and pregnancy and postpartum support programs, and behavioral health noting that engagement levels are low but have improved recently with changes to outreach.

During the presentation, Trustee Nasir was excused from the meeting at 9:55 a.m. and returned to the meeting at 10:02 a.m.

The meeting recessed at 10:15 a.m. and reconvened at 10:20 a.m.

D. HMSA Evidence-Based Programs

1. AccordantCare Rare

Mr. Jeff Dragsten, Ms. Melaca Cannella, and Mr. Nathan Reeves, CVS (HMSA's subcontractor), provided an update on the first year of the AccordantCare Rare program that provides support for members with 19 conditions, effective January 1, 2022 for EUTF and HSTA VB active employees noting the following for calendar year 2022:

- EUTF participation rate of 26% is comparable to HMSA and national rates.
- Return on investment of 1.37:1

CVS noted that the future targeted ROI is 2:1.

MOTION was made and seconded to recommend to the Board adopting the AccordantCare Rare program for the EUTF and HSTA VB retiree HMSA medical plans effective January 1, 2024. (Wataru/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-4/Employee-Beneficiary Trustees-4)

2. Supportive Care

Dr. Toby Smith, HMSA, presented the HMSA supportive care program (SC) which is a regular benefit under the EUTF and HSTA VB active plans and a pilot program under the EUTF and HSTA VB retiree plans through December 31, 2024. SC provides palliative, holistic care for members with serious or life-threatening conditions.

Costs were avoided for the 2022 SC enrollees as compared to a control group. This was the fourth out of five years in which costs were avoided due to the SC program.

MOTION was made and seconded to recommend to the Board adopting a palliative care program for the EUTF and HSTA VB retiree HMSA medical plans effective January 1, 2024. (Wataru/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-4/Employee-Beneficiary Trustees-4)

E. Upcoming Plan Changes

Mr. Mizuno summarized upcoming and previously discussed plan changes.
