I. CALL TO ORDER

The meeting of the Board of Trustees of the Hawaii Employer-Union Health Benefits Trust Fund (EUTF) was called to order at 9:00 a.m. by Chairperson Jacqueline Ferguson-Miyamoto, in the EUTF Board Room, 201 Merchant Street, Suite 1700, Honolulu, Hawaii, on Tuesday, September 26, 2023.

Chairperson Ferguson-Miyamoto announced new Trustee Ryan Yamane, Deputy Director Department of Human Resource Development and former Representative, and new Chief Investment Officer, David Okamoto.

II. REVIEW OF MINUTES – AUGUST 29, 2023

The Board reviewed the draft minutes of August 29, 2023.

MOTION was made and seconded to approve the minutes of August 29, 2023, as circulated. (Wataru/Yu) The motion passed unanimously. (Employer Trustees-5/Employee-Beneficiary Trustees-5)

III. OLD BUSINESS

- A. Benefits Administration System Implementation and Enrollment Processing Status Update Ms. Donna Tonaki and Mr. Brent Griffiths, TELUS Health, provided an update on the implementation of the new Benefits Administration System (BAS) and enrollment processing noting the following:
 - A software upgrade is planned for September 30 and TELUS Health has created a Pre-Prod environment to address issues with the usual test environment.
 - EUTF and TELUS Health continue to manually review and adjust errors on the semi-monthly payroll files. TELUS Health is focusing on resolving issues that are causing the errors to eliminate the manual intervention.
 - Collection of double refunds from BU11 members related to retroactive adjustments will be collected through the end of September. Refunds for 345 County of Maui and County of Hawaii BU11 members must still be processed.
 - Payroll issues related to pre go-live changes in coverages between January 16 April 30, 2022 are being manually resolved.
 - Payroll and other accounting reports are being worked on.
 - Death imports and SSI Medicare Part D enrollment continue to be worked on with SilverScript, the Department of Health, and TELUS Health.

Outstanding enrollment forms are comparable (461) to the previous comparable year (September 2021 - 564).

Trustee Audrey Hidano reminded TELUS Health to adhere to deadlines and not let dates slip.

B. Maui Update

Mr. Derek Mizuno recommended continuing to not cancel members for non-payment and waiving submission deadlines for qualifying events for members with Maui addresses for October.

MOTION was made and seconded to waive EUTF Administrative Rules section 4.11(b) Cancellation Due to Failure to Pay Contribution Shortage and section 4.05(b) Failure to File Properly Completed Enrollment Application Within the Prescribed Time for the month of October 2023 for members with Maui addresses. (Yu/Nasir) Trustee Audrey Hidano asked why the waiver was for all members with Maui addresses. Mr. Mizuno noted that it would be difficult to determine which members were impacted and the number of waivers has been minimal. The motion passed unanimously. (Employer Trustees-5/ Employee-Beneficiary Trustees-5)

Mr. Mizuno noted that Trustee Yamane will fill the vacancies on the Benefits and Investment Committees. Trustees Christian Fern and Yamane will join the Administrative Committee.

V. INVESTMENT COMMITTEE

A. Quarterly Performance Report – Q2 2023

Mr. Colin Bebee, Meketa Investments, highlighted significant points in the Q2 Performance Report. The OPEB Trust Fund portfolio finished the quarter at \$6.3 billion and gained 3.0% and 4.6% for the quarter and fiscal year (net of fees), respectively, underperforming the policy benchmark of 3.5% and 6.5%, respectively. Since inception (June 23, 2011), the portfolio has returned 7.2% (net of fees) versus the policy benchmark return of 7.1%.

Mr. Bebee reported that the EUTF Trust Fund portfolio finished the quarter at \$542.4 million, up 2.6% and 4.7% for the quarter and fiscal year (net of fees), respectively. Since inception (October 1, 2013), the portfolio has returned 3.3% (net of fees).

During Meketa's presentation, the Committee, Meketa, and EUTF staff discussed the recent underperformance and the impact of government shutdown, and how as long-term investors, we focus on the long-term asset allocation.

B. Quarterly Private Equity Report – Q1 2023

Mr. David Okamoto noted that since reporting for private market investments is lagged by one quarter, the three private market reports cover first-quarter 2023. At the end of the quarter, Private Equity reported a market value of \$648.6 million, with a since inception internal rate of return of 18.1% (net of fees), outperforming the asset class benchmark of 8.2%.

C. Quarterly Private Credit Report – Q1 2023

Mr. Okamoto noted that at the end of the quarter, Private Credit reported a market value of \$420.5 million with a since inception internal rate of return of 8.5% (net of fees), outperforming the asset class benchmark of 5.7%.

D. Quarterly Real Assets Report – Q1 2023

Mr. Okamoto noted that at the end of the quarter, Real Assets reported a market value of \$616.6 million with a since inception return of 7.5% (net of fees), outperforming the asset class benchmark of 7.1%.

The Trustees discussed how private market investments are monitored through quarterly financial statements and reports from the private market funds.

E. Investment Policy Statement Update

Mr. Okamoto presented the updated Investment Policy Statement, incorporating the investment guidelines for Gateway Investment Advisors.

MOTION was made and seconded to approve the Investment Committee's recommendation of approval of the updated Investment Policy Statement. (Wataru/Yu) The motion passed unanimously. (Employer Trustees-5/Employee-Beneficiary Trustees-5)
