

# See your doctor for a checkup and a chance to win \$1,500



When you prioritize your well-being, you're on the winning path to better health. Plan to visit the doctor every year, even if you don't feel sick. Seeing your doctor for preventive care is the best self-care strategy.

With HMSA your health plan includes an annual preventive health evaluation at no cost when you see a primary care provider (PCP) in HMSA's network. Your PCP checks your overall health and works with you to determine which screenings are recommended for you.

There's another way to win. **If you visit your PCP for an in-person annual evaluation and log in to My Account, you'll be entered in a drawing for a chance to win a \$1,500 Visa gift card. Virtual and phone appointments don't qualify for entry.**

## STEP 1 Schedule your exam



Call your PCP to schedule your annual preventive health evaluation if you have not already completed one in the last year.

Having a PCP means you have a health care partner who can help you track your progress toward your health and well-being goals and answer any questions you may have about medications, treatment plans, or other health issues. If you don't have a PCP, finding one is a click away. Visit [hmsa.com/eutf](https://hmsa.com/eutf) and click Find a Doctor to start your search. Or call us at (808) 948-6499.

Active EUTF members can complete their annual preventive health evaluation with their PCP by Oct. 31, 2024, for a chance to win a \$1,500 Visa gift card. Members who complete their exam between July 1, 2023, and Oct. 31, 2024, are eligible to enter.

## STEP 2 Log in to My Account



Log in to My Account on [hmsa.com/eutf](https://hmsa.com/eutf) by Oct. 31. To register for My Account, click My Account Login, use your personal email address, and enter your HMSA subscriber ID number. If you're already registered, log in and confirm that your email address is current.

**For EUTF Active members**, one annual preventive health evaluation is covered for members 22 and older when received from your PCP, including an assessment of any other preventive screenings you might need.
