B. Strategic Plan Update as of December 31, 2023

Mr. Derek Mizuno provided an update on the Strategic Plan as of December 31, 2023 noting that this update focuses on Goal 2 to reduce by 10% the projected actuarial accrued liability at July 1, 2025 and the projected annual required contributions for the period July 1, 2027 through June 30, 2044 from the July 1, 2021 actuarial valuation. The projection from the July 1, 2023 actuarial valuation shows EUTF meeting the goal. Based on preliminary estimates of the January 1, 2025 retiree premiums, the July 1, 2024 actuarial valuation may have an actuarial gain related to healthcare premiums. Trustee Wesley Machida asked for projections from the actuary to maintain the same annual required contributions for the State while shortening the amortization period.
