October 22, 2024 meeting noting the following:.

- There is no longer a distinction between excepted (subject to ACA active medical and prescription drug coverage) and non-excepted (not subject to ACA all other benefits) benefits. Dependent children are eligible for active employee and retiree medical, prescription drug, dental and vision plans effective July 1, 2025 through the end of the month in which the child turns age 26 (limiting age), including surviving children (with no surviving parent) of deceased retirees and active employees killed in the performance of their duty. Dependent children may be married, do not have to live with the subscriber and may be financially independent.
- There is no longer the need for the full-time student requirement and definition.
- The eligibility criteria for adult, disabled children was not changed.

MOTION was made and seconded to recommend to the Board approval of the proposed EUTF Administrative Rule Changes. (Machida/Fern) The motion passed unanimously. (Employer Trustees-2/Employee-Beneficiary Trustees-2)
