### I. CALL TO ORDER

The meeting of the Board of Trustees of the Hawaii Employer-Union Health Benefits Trust

Fund (EUTF) was called to order at 9:00 a.m. by Vice Chairperson Robert Yu, in the EUTF Board Room, 201 Merchant Street, Suite 1700, Honolulu, Hawaii, on Tuesday, April 22, 2025.

## II. REVIEW OF MINUTES – MARCH 24, 2025

The Board reviewed the draft minutes of March 24, 2025. Since there were no edits or objections by the Trustees, the minutes stand approved.

### III. NEW BUSINESS

A. Claims Audit Report – PSG Prescription Claims Audit of CVS/SilverScript for Active Employees July 1, 2021 – June 30, 2022 and Retirees January 1, 2021 – December 31, 2022

Ms. Serah Greenwalt, Ms. Lauren Johnson, Ms. Libby Johnson and Ms. Mandy Thompson of PSG presented the results of their claims audit of CVS/SilverScript for active employees July 1, 2021 – June 30, 2022 and retirees January 1, 2021 – December 31, 2022 noting that additional amounts are due from CVS/SilverScript related to the financial guarantees, generic dispensing rate guarantees and rebates. Trustee Wesley Machida asked if the findings were similar to prior years. Ms. Sandra Benevides, CVS, responded that there were similar findings in previous years. Because the previous audit timing (finalized in 2023), corrections to address the previous audit issues were implemented after this current audit period. Mr. Derek Mizuno noted that PSG will be auditing for active employees July 1, 2022 – June 30, 2024 and for retirees calendar year 2023 under the current supplemental contract.

Trustee Christian Fern entered the meeting at 9:25 a.m., during the audit presentation.

B. New Chairperson (Employee Trustee), Vice Chairperson (Employee Trustee) and Secretary-Treasurer (Employer Trustee) Effective July 1, 2025

Mr. Mizuno informed the Board that they can select a Chair and Vice Chair from the employee trustees and a Secretary-Treasurer from the employer trustees today, or at the May or June Board meetings for a July 1, 2025 effective date.

MOTION was made and seconded to appoint Trustee James Wataru as Chair of the Board and Trustee Osa Tui as Vice Chair of the Board effective July 1, 2025. (Fern/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-4/Employee-Beneficiary Trustees-5)

Selection of the Secretary-Treasurer was deferred to the next meeting.

## C. Committee Assignments

Mr. Mizuno informed the Board that the current committee assignments were included in the packets as informational only.

## IV. OLD BUSINESS

- A. Benefits Administration System
  - 1. Status Update

Ms. Amy Bell, TELUS Health, provided an update on the implementation of the new Benefits Administration System (BAS) noting that the payroll and other accounting reports, death file import and Medicare expiry issues from previous updates are all in

Production. TELUS Health and EUTF staff are working on the new items added this report and from the January 2025 report.

## 2. Member Portal Demonstration

Ms. Jessica McDonald walked the Trustees through the new hire member portal experience and obtained feedback for staff to discuss with TELUS Health. In addition, she presented the updated EC-1 enrollment form that makes the monthly premiums more visible for the members.

Trustee Nasir was excused from the meeting at 10:19 a.m. during the demonstration.

# B. 2025 EUTF Related Legislation

Mr. Mizuno noted that the EUTF Board's bill related to the base monthly contribution was enrolled with the Governor and the request to add an Investment Officer position was included in both the House and Senate budget drafts. Mr. Mizuno also highlighted the following bills:

- SB1651 SD1 HD2 requires posting of board materials at least two business days prior to the meeting. EUTF is currently in compliance.
- HB250 HD2 SD2 requires organizations that process prior authorizations to report data to the State and establishes a working group, which includes two EUTF Board appointees, to study and make recommendations regarding the use of prior authorizations.
- SB935 SD2 HD3 changes ERS vesting requirements for those hired on or after July 1, 2012 (and still employed) to 5-years instead of 10-years. If this bill passes, employers will only be responsible for reimbursing Medicare Part B premiums for the retiree and spouse, if the retiree was hired prior to July 1, 2023, since employers are not required to contribute any portion of the base monthly contribution for health care and life insurance premiums for retirees with less than 10-years of service.

### V. COMMITTEE REPORTS

## A. Investment Committee

1. Diversifying Strategies Education

Mr. Colin Bebee, Meketa Investments, summarized the education provided to the Investment Committee regarding diversifying strategies and the investment strategy basis (i.e., rules based, systematic and/or fundamental/discretionary) of a new manager in the alternative risk premia asset class.

## 2. Long Volatility Benchmark Change

Mr. Bebee presented the Investment Committee's recommendation to change the EUTF's long volatility benchmark. The long volatility strategy is a component of Diversifying Strategies and was incorporated into the portfolio in the summer of 2023. The strategy is currently benchmarked to the Eurekahedge Long Volatility Index (ELVI). Given changes in the ELVI benchmark construction, Meketa recommends the following steps:

- Maintain usage of the ELVI benchmark from inception through December 31, 2024.
- From January 1, 2025, transition to the With Intelligence Long Volatility Index.

> Adopt the HFR Long Volatility Index as the new long-term benchmark which was recently published and backfill performance to January 1, 2025, replacing any index returns from the With intelligence Long Volatility Index.

MOTION was made and seconded to approve the Investment Committee's recommendation to change the Long Volatility benchmark from the Eurekahedge Long Volatility Index to the With Intelligence Long Volatility Index effective January 1, 2025, then to the HFR Long Volatility Index. (Wataru/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-5)

## B. Benefits Committee

 CVS/SilverScript Semi-Annual Utilization Reports for the period ending December 31, 2024

Mr. Mizuno summarized the Benefits Committee Report related to this item.

- 2. Proposed CVS Prescription Drug Plan Changes
  - Mr. Mizuno summarized the Benefits Committee's recommendation regarding the EUTF active and non-Medicare retiree prescription drug plans as follows:
  - 1. Discontinue General Step Therapy Program (GSTP) for nine drug classes due to low savings.
  - 2. Continue GSTP for five drug classes
  - 3. Add GSTP to the antipsychotics class with grandfathering to not disrupt treatment. The Committee noted that CVS will discontinue two drug classes and no new classes will be added for the HSTA VB plans due to the court order.

MOTION was made and seconded to approve the Benefits Committee's recommendation to continue all available generic step therapy program options and add the anti-psychotic class to the generic step therapy program with grandfathering effective April 1, 2025 to the EUTF active and non-Medicare retiree prescription drug plans administered by CVS. (Tui/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-5)

The Committee will discuss possible delegation of GSTP changes to CVS at the next Committee meeting.

Mr. Mizuno summarized the Benefits Committee's recommendation to add the CVS non-specialty dermatological bundle with grandfathering. The bundle will require trial of lower cost options for 12 non-specialty dermatological drugs. Grandfathering is recommended due to a high number of members being disrupted and low projected savings.

MOTION was made and seconded to approve the Benefits Committee's recommendation to add the non-specialty dermatologic bundle with grandfathering to the EUTF active and non-Medicare retiree prescription drug plans administered by CVS effective July 1, 2025 and January 1, 2026, respectively. (Tui/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-5)
