### I. CALL TO ORDER

A. Benefits Administration System Status Update

Ms. Amy Bell, TELUS Health, provided an update on the implementation of the new Benefits Administration System (BAS) noting that the payroll and other accounting reports and death file import issues from previous updates were completed. TELUS Health and EUTF staff are working on the items added to this report in 2025.

B. 2026 Base Monthly Contribution and Retiree Premiums

Ms. Amy Cheung presented a memo dated July 17, 2025, regarding the 2026 Base Monthly Contribution (BMC) and Retiree Premiums noting that with the passage of Act 54, Session Laws of Hawaii 2025, we know the 2026 BMC. The 2026 BMC and 75% of the BMC are greater than the combined medical, prescription drug, dental and vision premiums for Medicare and non-Medicare retirees applicable tiers except for the 75% retirees with non-Medicare self plans who will be responsible for approximately \$20 monthly.
