(Tui/Wataru) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-4)

MOTION was made and seconded to recommend to the Board submission of a bill to remove the limitation in Hawaii Revised Statutes 87A-32, 33, 34, 35 and 36 that the employer contribution be no more than a family contribution, if both spouses are employees/retirees of the State and/or counties. (Tui/Wataru) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-4)

C. Supplemental Budget Request – July 1, 2026 – June 30, 2027
Ms. Amy Cheung summarized the Supplemental Budget Request for FY27 of an additional Investment Officer position.

MOTION was made and seconded to recommend to the Board approval of the supplemental budget request for July 1, 2026 to June 30, 2027. (Tui/Wataru) The motion passed unanimously. (Employer Trustees-3/Employee-Beneficiary Trustees-4)
