## Hawai'i Medical Service Association (HMSA) Official Rules for the

## Hawaii Employer-Union Health Benefits Trust Fund (EUTF) Sweepstakes

2025 Healthy Holiday Mindfulness Challenge

## By submitting an entry, you agree that you understand and accept the terms and conditions of these Official Rules:

- 1. **General.** No purchase is necessary to win a prize. You must be an active, retired, or dependent EUTF member and a legal Hawaii resident at the time of entry and the time of any prize award. You must be at least 18 years old to enter. You must provide your personal email address and additional contact information upon entering. You may only enter on your own behalf. Hawai'i Medical Service Association ("HMSA") is the administrator of the EUTF 2025 Healthy Holiday Mindfulness Challenge Sweepstakes ("Sweepstakes").
- 2. **Eligibility.** Employees of HMSA are not eligible to enter or win. EUTF members may enter other HMSA administered Sweepstakes, if eligible.
- 3. **Promotional period.** The promotion for the chance to win a maximum of one of the prizes set forth in section 6 below will begin on December 1, 2025, at 12:01 a.m., HST and end on December 26, 2025 at 11:59 p.m., HST ("Promotional Period").
- 4. **How to enter.** To enter into the Sweepstakes, participants must complete the 2025 Healthy Holiday Mindfulness Challenge by registering into the 2025 Healthy Holiday Mindfulness Challenge and completing the registration form online, provided via emailed <u>link</u> from HMSA to all EUTF members by December 5, 2025 at 11:59p.m. HST and enter their Mindful Minutes activities before the reporting deadlines outlined in section 5. This Sweepstakes consists of two challenges:
  - a. "Weekly Challenge": To be eligible to win a Weekly Challenge prize, participant must 1) register to enter the 2025 EUTF Healthy Holiday Mindfulness Challenge and 2) log in their weekly Mindful Minutes by the weekly reporting deadlines outlined in section 5. Participants who complete both requirements are granted one (1) entry per week of Mindful Minutes entries with a chance to win an HMSA prize pack. There will be one winner selected per week. HMSA prize packs are HMSA logo items therefore no tax reporting will be necessary.
  - b. "Healthy Holiday Mindfulness Challenge": To be eligible to win, participant must complete the 2025 Healthy Holiday Mindfulness Challenge by: 1) registering into the 2025 Healthy Holiday Mindfulness Challenge by December 5, 2025 at 11:59p.m. HST; 2) performing a minimum of 600 minutes of mindfulness activities that fall within the "Mindful Minutes" categories listed below by the end of the Promotional Period; and 3) logging Mindful Minutes performed online at the website provided by HMSA by December 29, 2025 at11:59 p.m. HST. Participants who complete all three requirements are granted one (1) entry into the Healthy Holiday Mindfulness Challenge Sweepstakes, with a chance to win one (1) of ten (10) \$150 Amazon e-gift cards. Participants are limited to one entry into this drawing. Entries are automatically generated after participants complete the 2025 Healthy Holiday Mindfulness Challenge in its entirety. Refer to section 7 for tax reporting on e-gift cards.
    - i. Mindful minutes entries fall into one of the following 4 activities: 1) Mindfulness in stillness meditation, breathing exercises, mindful breaks, body scans, and related activities; 2) Mindful movement walking, stretching, yoga, and other physical activity integrated with mindfulness; 3) Mindful eating eating meals without distractions such as phones and screens, savoring flavors, textures, and being present; 4) Mindful reflection daily reflection through journaling, gratitude practices, progressive muscle relaxation, gentle massage therapy, arts, crafts, music and other activities that integrate mindfulness and reflection.

Alternate method of entry consists of sending an email with the subject line "2025 Healthy Holiday Challenge" with your first name, last name, date of birth, phone number, full address including zip code, and email address to the following email address: well-being@hmsa.com. Participants can

- only win a maximum of one Weekly Challenge prize and one Healthy Holiday Challenge during the promotional period regardless of method of entry.
- 5. **Effective date of entries.** Entries received within the Promotional Period will be eligible for entry into the Sweepstakes. Email entries must be received by the close of the Promotional Period. All entries become the exclusive property of HMSA and will not be acknowledged or returned.

- 6. **Prizes and odds of winning.** The Healthy Holiday Challenge Sweepstakes prize will be a chance to win one (1) of ten (10) \$150 Amazon e-gift cards (eligible participants are limited to winning one prize). The odds of winning will be determined by the number of eligible entries received. Each eligible entry has an equal chance of winning a prize. You may only win one e-gift card during the Promotional Period.
- 7. **Selection of winners.** The winners will be determined by a random drawing by HMSA from all eligible entries received. The winners' names will be drawn for the prizes no later than thirty (30) days after the close of the Promotional Period. By accepting their prize, the winner agrees to these Official Rules, and has the option of including the use of their name, voice, and/or likeness for the purpose of announcing the winner of the promotion without further compensation. If the winner does not agree to be bound by these Official Rules, their prize will be forfeited and another winner will be chosen. All prizes are nontransferable, and no cash or other prize substitution will be permitted except at HMSA's sole discretion. Winner is solely responsible for reporting and payment of any taxes on a prize. Winner will be required to provide his/her valid Social Security number to HMSA for tax purposes and/or complete an IRS W-9 form in order to claim a prize. Active EUTF member winners employed by the State of Hawaii will have the value of the prize added into their payroll and IRS W-2 form. Active EUTF member winners employed by the counties of Kauai, Maui, Hawaii, and the City of County of Honolulu will complete an IRS W-9 and will be sent a form 1099 from HMSA. An EUTF Retiree or dependent of an active member or retiree, will complete an IRS W-9 and will be sent a form 1099 from HMSA. All Winners are solely responsible for all federal, state and local taxes on prize value, as applicable. The Weekly Challenge prize winners are HMSA prize packs which are logo items therefore no tax reporting will be necessary.
- 8. **Notification of winners.** The winners of the prizes will be notified by email at the email address provided at entry. Prizes will be delivered to the email address provided at entry. All decisions are final and binding. Winner must contact HMSA within five (5) business days from the date the notification is sent or made by HMSA to claim their prize. Failure to contact HMSA within that five (5) business day period will result in immediate disqualification of the selected entrant and a new winner will be selected. No exceptions will be made to this rule. HMSA is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winners. - or (VI) any printing or typographical error in any material associated with the drawings. - 11. **Privacy.** We are required by law to maintain the privacy and security of your personally identifiable health information. HMSA will never disclose any of your personal information either publicly or to the employer, except as necessary to respond to a request from you for a reasonable accommodation needed to participate in the Sweepstakes, or as expressly permitted by law. Medical information that personally identifies you that is provided in connection with the Sweepstakes will not be provided to the EUTF or your employer. None of the health information you provide may be used in making any employment-based decision. Your health information will not be sold, exchanged, transferred, or otherwise disclosed except to the extent permitted by law to carry out specific activities related to the Sweepstakes or other plan services, and you will not be asked or required to waive the confidentiality of your health information as a condition of participating in the Sweepstakes or receiving an incentive. For instances, applicable employers will be notified of active employee winners for purpose of payroll tax deduction on the prize.
