MOTION was made and seconded to approve the Benefits Committee's recommendation to add a 30-day initial fill limit on anti-diabetic and anti-obesity medication GLP-1s under the EUTF active and non-Medicare retiree prescription drug plans administered by CVS effective January 1, 2026. MOTION was made and seconded to approve the Benefits Committee's recommendation to add coverage of continuous glucose monitors and disposable insulin pumps with utilization management under the EUTF and HSTA VB active and non-Medicare retiree prescription drug plans administered by CVS effective July 1, 2026. subsidies are projected to be more than what was anticipated when the original rates were approved. This increase in subsidies lowers the EUTF retiree rates.

MOTION was made and seconded to approve the revised CVS and SilverScript prescription drug plan retiree premiums effective January 1, 2026 as recommended by Segal. (Tui/Ferguson-Miyamoto) The motion passed unanimously. (Employer Trustees-4/Employee-Beneficiary Trustees-5)
